 - Beth Trenchard, Monterey Bay Community Power, informed the Board that MBCP is looking for volunteers for their advisory committee.
 - Ramona Andre expressed concern about impacts beach fires and fireworks have on air quality.
 - Richard Andre spoke on the same issue.

 - Director McShane thanked the District for participating in Salinas Founders Day and announced the Earth Day Mixer on April 19. He also recommended that staff look into ways to encourage attendance at the District's budget workshops.
- 8. Report From Air Pollution Control Officer

Richard Stedman, APCO, reported on the following:

District Business

- A new engineer, Osiris Torres, joining the District staff on May 7.
- Compliance Division sent out advisories to a subset of the permitted gasoline tanks regarding requirements to change out hoses this year. The advisories are also posted to the District's website.
- A Hearing Board meeting will be held on April 19 to review a long term variance request from the Monterey Regional Waste Management District.

- Two budget workshops have been held to date; one in Hollister and one at the District office. The Santa Cruz workshop is Tuesday, April 24 at 11:00 am at the Watsonville Library.
- Application period for the AB2766 grants is currently open for public agencies for infrastructure projects and EV vouchers.
- Applications will be available soon for EV rebates for residents living in the District, with additional incentives for low income residents.
- The District recently tentatively allocated funds from the following programs:
 - o \$113,000 from the Moyer Program State Reserve
 - o \$1.3 million from CARB's FARMERS Program for Ag equipment; and
 - o \$614,000 from the Community Air Protection Program.

All of these funds will be distributed according to the District's Carl Moyer Memorial Grant Program guidelines and other program specific requirements.

 Three seasonal PM2.S air monitoring devices in the San Lorenzo Valley will be temporarily shut down at the end of the month as the air quality improves into the Spring and Summer.

- District will have a booth April 19 at McShane's Earth Day Mixer.
- Participation in Founders Day last Saturday, April 14.
- YMCA Healthy Kids Day in Hollister on April 21.
- Deadline for Nominations for Clean Air Leaders Awards is April 30.

ALA State of the Air Report

- Air quality getting worse due to climate change. Specifically, warmer days are causing higher ozone levels. More fires from drought conditions.
- Political pulpit to argue against weakening the Clean Air Act and for using science.
- Salinas mentioned as one of two of the cleanest cities for ozone and year round PM2.5. Scored in the top 25 cleanest cities for annual PM2.5
- Monterey and Santa Cruz are included with the cleanest counties in US for ozone pollution, Both received "A" grades. San Benito received a "D" grade.
- San Benito received an A grade for PM2.S 24-hr concentrations. Both Monterey and Santa Cruz received F grades. All counties received a PASS for annual PM concentrations







Greenhouse Gas Emission Standards for Crude Oil and Natural Gas Facilities (effective 10/1/2017)

Regulation addresses fugitive and vented methane (CH4) emissions from both new and existing oil and gas facilities.

Covered facilities:

Oil and Gas Production, Processing, and Storage
Gathering and Boosting Stations
Natural Gas Underground Storage
Compressor Stations

Purpose of MOA Specify roles and responsibilities Enforcement coordination Support information and data sharing Registration program for equipment not covered by districts



Leak Detection and Repair

- Daily inspections and quarterly testing to check components for leaks.
- Exemptions for components such as those on produced water lines downstream of separator and tank system with vapor control.

Upcoming Dates

- January 1, 2018
 - Registration (extended to July 1, 2018)
 - LDAR inspections begin
 - Flash testing begin
- January 1, 2019
 - Vapor collection on separator and tank systems if greater than 10 metric tons per year CH4
 - Less than 10 metric tons conduct annual flash test



Recommendation

- Adopt Resolution to:
 - Authorize APCO to enter MOA with the California Air Resources Board;
 - Authorize APCO to sign MOA administrative amendments upon District counsel review;
 - Authorize FY17-18 general fund budget adjustment to receive \$85,000 from CARB.
